

ACRL Seeks Volunteers for Offices and Committees

Would you like to run for an ACRL office or volunteer for appointment to an ACRL standing committee? Are you interested in seeking office in an ACRL section or being considered for appointment to a section committee? If the answer is yes to either of these questions, here's how to proceed.

ACRL PRESIDENT

The ACRL Appointments and Nominations Committee will nominate candidates for the office of ACRL vice-president/president-elect at the January 1980 Midwinter Meeting of ALA. The election for this office will be held in the spring of 1981. The winner of the election will serve as vice-president/president-elect during 1981-82 and as president of ACRL during 1982-83. ACRL COMMITTEES

ACRL has eighteen standing and ad hoc committees: Academic or Research Librarian of the Year Award Committee, Academic Status Committee, Appointments and Nominations Committee, Audiovisual Committee, Budget and Finance Committee, Chapters Committee, Conference Program Planning Committee, Constitution and Bylaws Committee, Continuing Education Committee, Copyright Committee (ad hoc), Legislation Committee, Membership Committee, National Conference Committee, Planning Committee, Publications Committee, Standards and Accreditation Committee, Standards and Accreditation Committee—*Standards for College Libraries* Revision Subcommittee (ad hoc), and Supplemental Funds Committee. When scheduled vacancies occur on ACRL standing committees, the Appointments and Nominations Committee recommends to the president-elect of ACRL the names of members who might fill the vacancies. The president-elect makes the final appointments. If you are interested in being considered for appointment to an ACRL committee, you should complete the ACRL Committee Volunteer Form that is in-

cluded in this issue of *CBRL News* and mail it to Russell Shank, chair of the Appointments and Nominations Committee, before January 15, 1980.

ACRL SECTION OFFICES

ACRL has thirteen sections (their names are listed later in this article). You will find a description of their areas of responsibility in the *ALA Handbook of Organization*. Each section has an executive committee and a nominating committee. The nominating committee nominates persons to run for the elective offices of the section. The major offices of a section are the chair and vice-chair/chair-elect. Some sections also elect secretaries and members-at-large to the section executive committee. If you would like to run for the office of vice-chair/chair-elect of a section or for secretary or member-at-large, contact the chair or a member of the appropriate section nominating committee (see "People to Contact," below) before January 15, 1980.

ACRL SECTION COMMITTEES

The committees of ACRL sections offer a variety of opportunities for service to the division. The Community and Junior College Libraries Section alone has ten committees. For a complete listing of ACRL section committees, see the *ALA Handbook of Organization*.

The chair-elect of a section appoints the chair and members of all section committees when scheduled vacancies on these committees occur. If you would like to be considered for appointment as chair or member of a section committee, fill out the ACRL Committee Volunteer Form and mail it to the chair-elect of the appropriate section (see "People to Contact," below) before January 15, 1980.

EDITORIAL BOARDS

ACRL has five editorial boards: the *Choice* Editorial Board, the *College & Research Libraries* Editorial Board, the *College & Research Libraries News* Editorial Board, the *Nonprint Media Publications* Editorial Board, and the *Publications in Librarianship* Editorial Board. When a vacancy occurs on an editorial board, the editor recommends the name of a person to fill the vacancy. The Publications Committee must approve the recommendation. The ACRL board must give its approval, and finally the president of ACRL makes the appointment.

If you would like to be considered for ap-

pointment to an editorial board, contact the editor of the publication (see "People to Contact," below).

Remember that at any given time there are only a limited number of vacancies on ACRL's committees, sections, and boards. If at once you don't succeed in obtaining an appointment, try again. Make yourself known to committee chairs by sitting in on meetings, volunteering to help with committee projects, etc. If committee chairs see that you are interested in the work of their committees, they may recommend your name to the appropriate appointing body when a vacancy occurs.

RISE IN ROYALTIES FOR ON-LINE SEARCHING PREDICTED

The royalties that data base producers charge for on-line searching of their products will roughly double by 1985, says a report by Patrick Barwise of the London Business School. The report predicts that other direct costs of searching (the charges levied by searching services and telecommunications operators) will continue to drop. But, because royalties will double, the total direct costs of searching will fall less than many observers have expected.

The report asserts that data base producers have kept on-line royalties low in order to encourage on-line searching. As a result, the users of the printed forms of data bases are now, in effect, subsidizing on-line users. To continue this pricing policy after on-line searching has taken hold, however, risks precipitating a fall in the sale of printed products. Thus, data base producers are likely in the future to charge higher royalties for on-line searching and to limit price increases for printed products.
