Profiles

DOUGLAS G. BIRDSALL has been named associate director of libraries for information access and systems at Texas Tech University Libraries. Birdsall has been at the North Dakota State University Libraries in Fargo since 1984, serving as head of public services and, most recently, as assistant director for collection management and reference services. Before that he was humanities librarian at the Idaho State University Library. Birdsall graduated from the University of Michigan with a B.A., then received an M.A. from Central Michigan University, and an MLS from the University of Michigan. He is a member of ALA and was chair of the Academic Section of the Mountain-Plains Library Association in 1988–1989.

In 1985 Birdsall received a grant for "Database Searching: A Proposal for Creating Awareness and Developing Skills" from the Faculty Development Institute at NDSU. In 1982 he received a grant for "Library Use Improvement: Subject-Oriented Library Guides for Upper-Division Students" from the Center for Instructional Improvement, Idaho State University. In both 1988 and 1989 he edited the *Proceedings of the Mountain-Plains Library Association Academic Section Research Forum*. Other publications include "Library Skills and Freshman English: A Librarian's Perspective" in *College Composition and Communication*, and *Dissertations and Theses About Idaho, 1900–1978*, published in 1980. Birdsall received ALA's H. W. Wilson Periodical Award for the editorship of *The Idaho Librarian* in 1983.

RHODA K. CHANNING, assistant university librarian of Boston College, has been appointed library director at Wake Forest University, Winston-Salem, North Carolina. During her 25-year career, Channing has worked in the libraries of the University of North Carolina at Chapel Hill, the University of Kentucky, and Boston College. She is a frequent

speaker at professional meetings, has served on the ALA Committee on Accreditation, and was an officer of the New England Chapter of ACRL

WILLIAM C. ROSELLE, director of the Golda Meir Library at the University of Wisconsin-Milwaukee since 1971, has been appointed director of the University Library System at the University of Pittsburgh. Roselle graduated from Thiel College and received an MLS from the University of Pittsburgh. He has served professionally at the University of Iowa, the Pennsylvania State University, Carnegie-Mellon University, the State Library of Pennsylvania, the Milton Hershey School, and the United States Army's Counterintelligence Corps. During his 18 years in Wisconsin, Roselle increased the Meir Library holdings from 900,000 to more than 3,500,000 cataloged items, directed the design and construction of nearly \$20 million in library facilities, and was responsible for the 1978

transfer of the American Geographical Society Collection from New York City to Milwaukee.

Roselle is a life member of ALA, an honorary fellow of the American Geographical Society, and a member of numerous other professional associations. He received the Distinguished Alumnus Award from Thiel College in 1985, the Exceptional Service Award from the Wisconsin Society for Jewish Learning in 1987, and a special citation from the Special Libraries Association in 1979.

VIRGINIA ANDREWS, Texas Tech University Libraries Automation Coordinator, has received a 1989 Outstanding Achievement Award from Texas Tech University. Andrews has worked for the University Library for 29 years as cataloger, assistant head of cataloging, head of cataloging, and OCLC coordinator. She is a member of ALA and vice-chair/chair-elect of the Automation and Technology Interest Group of the Texas Library Association.

CHARLOTTA HENSLEY, assistant director for research and development at the University of Colorado at Boulder Libraries, has received the 1988-89 President's University Service Award. Hensley was recognized for the amount of time and effort she volunteered as editor of *Frontiers: A Journal of Women Studies*. Her \$2,000 award will be given to the journal at her request. An active member of ALA and ACRL, Roberts chaired the Bibliographic Instruction Section in 1981-1982 and initiated the pre-ALA dinners and the Morris Jones traveling workshops. She has authored several books and articles in the fields of bibliographic instruction, public relations, and children's literature, and currently serves on the board of the Library Literacy Project under the auspices of the American Reading Council in New York City.

RONALD E. WYLLYS, dean of the University of Texas at Austin's Graduate School of Library and Information Science, has announced his resignation from that position effective August 31, 1990. He plans to return to full-time teaching and conducting research in computer processing of natural language information and quantitative linguistics. Wyllys joined the UT Austin faculty in 1972 as an assistant professor. He has taught courses in research methods, systems analysis and design, library automation, library operations research, and the GSLIS basic introductory course. He has also taught a seminar on the future of information science. Wyllys was named acting dean of the GSLIS in August 1982 and was appointed dean of the school in March of 1984. Under his direction the number of doctoral students has more than doubled and the GSLIS Foundation has grown from approximately \$137,000 to approximately \$810,000. The school was also the first in North America to establish two endowed professorships in archives education.

Alkaline paper at Tulane

This fall, Francis L. Lawrence, academic vice-president and provost at Tulane University, is sending out a memo to deans, directors and department heads, informing them of the availability and choice of acid-free paper, thanks to university librarian Philip E. Leinbach. The copy center and bookstore are also changing their signage, order forms, and information available from clerks so that individuals can make a conscious decision when choosing paper as to whether or not it will be acid-free.

It all started when Leinbach sent a one-page memo to Lawrence regarding "Publications on Permanent Paper." His statement of the problem and suggestions for action tie in well with the national preservation program:

"Research libraries are engaged in a massive effort to preserve books that in the last hundred years have been printed using acidic paper and are now crumbling away. Using both private and public funds, programs to capture the contents of millions of volumes are well underway.

"At the same time we must forestall future problems by printing today's books on permanent paper (also called 'alkaline' or non-acidic paper), I am requesting your support in several ways."

Leinbach then went on to ask that the faculty be informed of the importance of permanent paper and that they be encouraged to require publishers of their articles and books to use such paper, that there be a policy decision that all university publications of enduring value be printed on permanent paper, and that persons responsible for sources of paper make permanent paper available at the university.

ACRL's *Choice* magazine is now adding acid-free paper information to the bibliographic entries that accompany their book reviews. *Choice* will report whether the book that is sent out for review is printed on alkaline paper. The information will be taken either from the book itself or from the LC MARC record.—*Commission on Preservation and Access Newsletter, July 1989.*

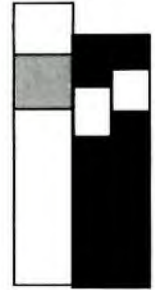

- ***California Legal History Manuscripts in the Huntington Library: A Guide***, prepared by the Committee on History of Law in California of the State Bar of California (233 pages, July 1989), represents the culmination of work begun in 1984 when Gordon Bakken began the task of cataloging the Huntington's legal history special collections. The guide has two major parts: a subject access guide that refers to individual documents and sets of documents by topic; and a description of collections of interest to legal historians. The manuscripts described are primarily from the 19th century and involve real estate, agriculture, and such industries as mining, oil, and commerce. - ***Campus Trends, 1989***, by Elaine El-Khawas (48 pages, July 1989), has been published as Higher Education Panel Report no. 78 by the American Council on Education. This is the sixth in an annual series of ACE surveys of academic and administrative practices of American colleges and universities. In this report, special attention was given to campus faculty and activities to improve minority participation in higher education. Tables show patterns of faculty hiring, current and expected shortages of faculty by subject area, the current status of student assessment, and changes in enrollment. - ***PC USA***, released in August by PC Globe, Inc., is a unique, PC-based software package that combines maps, graphics, and statistics to give users an instant profile of all 50 states and Puerto Rico. With *PC USA* installed at the reference desk, staff or students can find data on population, ethnic

groups, births, deaths, divorces, hospital beds, dentists, pharmacists, elementary schools, colleges and universities, crime, natural resources, agriculture, gross state product, average annual pay by industry, state sales tax, corporate and personal income tax, state revenues and expenditures, motor vehicle registration, public road mileage, gasohol consumption, government, history, and tourist attractions. The program is very easy to learn and works well both with or without a mouse. Other endearing features of this program are its ability to calculate the distance and bearings between any two cities, compare time zones across the country, find the location of any five-digit zip code or three-digit area code, and instantly show U.S. maps color-coded to the statistic you are interested in. State maps are also available that display populated places, features, and elevations. The program has the ability to export data to an ASCII or Lotus 1-2-3 file and export graphics to a .PCX file readable by most graphics or desktop publishing packages. It requires a minimum of 512K RAM and supports Hercules monochrome, CGA, EGA and VGA displays for IBM PC/XT/AT/PS2 or compatibles. MacIntosh and Apple II versions are now under development. A companion program, *PC-Globe+*, released earlier this year, provides similar statistics for every country in the world. For example, you can compare the literacy rate in Namibia with the 10 countries with the highest rate, or the number of nurses per person in Uruguay with the number in Czechoslovakia. The maps are excellent and especially detailed for some of the smaller countries, which often get glossed over in even the best printed atlases. The suggested retail price is the same as for *PC USA*.
