Deaths

LAURA MICHEL BOWMAN, chemistry librarian at the University of Houston Libraries, died October 3, 1988. A member of ALA and the Special Libraries Association, Bowman received her MLS from the University of Denver, then worked as technical librarian at the Exploration and Production Technology Library of Marathon Oil Company in Littleton, Colorado. Among her accomplishments at UH was her leadership of an innovative project to create and test an Electronic Information Service Pilot Project, with funding from the Dreyfus Foundation, to support research in chemistry.

FRANK CHALTON FRANCIS former director and principal librarian of the British Museum, died September 15 at the age of 86. Born in Liverpool, Francis attended Liverpool and Cambridge Universities and began his career as a schoolmaster. In 1926 he joined the BM staff where he later became secretary (1946-47), keeper in the Department of Printed Books, and director (1959-68). He was made CB in 1958 and KCB in 1960. Francis' main interest was in historical bibliography, in which he was active in writing and editing. He lectured for many years at the School of Librarianship at University College London. His many professional memberships included the London Group of the

University and Research Section of the Library Association, the Circle of State Librarians, and UNESCO, where he helped set up the International Advisory Committee on Bibliography. He was president of all the main associations including the Library Association, the Bibliographical Society, ASLIB, the Museums Association, and IFLA. As an editor, Francis worked on the publication *The Library* for 18 years, and *The Journal of Documentation* for 22 years. As a member of the BM staff he played a leading role in two very important programs: the founding of the *British National Bibliography*, and the publication of *GK III*, the third edition of the *General Catalogue of Printed Books*.

LORETTA HILL, a member of the Monographic Processing Services Department at Indiana University, Bloomington, died November 24 after a long illness. Hill began her career at IU in 1960 as a clerk typist in the Order Department, then moved on to the Automated Processing Department, where she worked as a cataloger until 1986.

MARY ELIZABETH MILLER SHAW, former librarian at Goucher College, Towson, Maryland, died November 26. A graduate of the University of Ar-

Should there be standards for hypertext?

The ALA Library and Information Technology Association (LITA) is exploring the question of technical standards for hypertext applications. Hypertext systems enable a user to establish linkages between related ideas within a document as well as among different documents. Such associative links may then be used for retrieval of related ideas. These linkages might also be established between materials in text form to related concepts in graphic, video, and audio media. In an environment of rapid development of such systems, LITA is seeking input on the advisability of establishing hypertext standards.

LITA's Technical Standards for Library Automation Committee is charged with encouraging, supporting, and, as appropriate, working with relevant organizations to establish standards relating to library and information technologies and telecommunications. The committee seeks to expand awareness of and broaden participation in the standards setting process. To this end, LITA is seeking input from a broad range of ALA members on the question of hypertext standards.

• ***The African Studies Information Resources Directory***, by Jean E. Meeh Gosebrink (572 pages, K.G. Saur, 1986), and ***The Arts of Central Africa: An Annotated Bibliography***, by Daniel P. Biebuyck (304 pages, G.K. Hall, 1987), are co-winners of the 1988 Conover-Porter Award, a \$300 prize given by the African Studies Association's Archives-Libraries Committee every two years. The 437 detailed entries of the *Information Resources Directory* provide a comprehensive reference and research tool to sources of information on sub-Saharan African materials located in the United States. This work was published for the African Studies Association, primarily with funding from a grant through the Research Collections Program of the National Endowment for the Humanities. *The Arts of Central Africa* annotates 1,920 monographs and scholarly articles that focus on the arts and their environment. Multi-disciplinary in coverage, it provides references to ethnographic and linguistic materials, especially to specific institutions, cultural features, or customs where the arts function. Ordering information can be obtained from the respective publishers.

• ***The AHE Vendor Directory for Acquisitions Librarians***, compiled by the Vendor Study Group of the Association for Higher Education of North Texas (152 pages, 1988), includes information on 134 vendors worldwide who are currently in use in the North Texas area or who were recommended for inclusion. Each entry in the directory gives address, phone number, office hours, chief executive officer, and local representative, as well as information concerning any specialties or services. A 13-page subject index provides access. The directory is available for \$15 (plus \$2 shipping, and another \$2

• ***The Anglo-American Cataloguing Rules*** (656 pages, 2d ed., 1988 revision) integrates the complete text of the 1978 revision (with corrections) and all changes authorized since then by the Joint Steering Committee for Revision of AACR. Special features of this revision include: additional rules and examples for new nonprint formats, including digital sound recordings and microcomputer software; new rules for manuscripts, music, and cartographic materials; unpublished revisions authorized since 1985 incorporated into the text; and additional examples for many existing rules. • ***The CUSS (Cooperative Union Serials System) List*** (15th ed., 1988) was created from the merged serials files of 13 university libraries in Ontario. Over 155,000 main entries are arranged alphabetically. Under each entry are library locations, years, volumes held, and call numbers. The list, on 95 microfiche at 42:1 reduction ratio, is produced at York University for the Ontario Council of University Libraries. The cost is \$75 (Canadian) for the first copy, and \$10 for each additional copy. • ***East-West: Hand Papermaking Traditions and Innovations***, by Alice Schreyer (55 pages, 1988), is a catalogue of an exhibition celebrating the vitality
