"Whether or not public lending right is actually inherent in copyright law, or merely a means of subsidizing authors employing library use as a convenient rationale," is debated in the pages of this symposium. 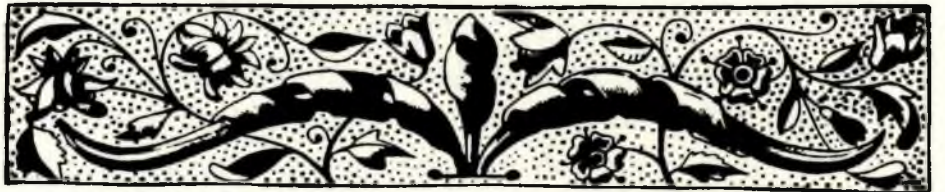
