

MSU Library awards faculty OER grants

The Michigan State University (MSU) Libraries Open Educational Resources (OER) Advisory Committee has awarded a second round of grants totaling \$28,500 to ten MSU faculty. The announcement was made by Dean of Libraries Joseph A. Salem Jr., who noted that the awards are designed to support the goals of the OER program, which aims to help instructors reduce costs for students, improve access to required texts, and increase student success.

The faculty members (and faculty member teams) will each receive \$4,000 to create and develop new OER for primary course material. LYRASIS, Columbia University Libraries announce e-books partnership

LYRASIS and the Columbia University Libraries recently announce a new partnership to bring SimplyE, an open source e-book management platform, to Columbia University Library users. This partnership will increase access to materials available from the Columbia University Libraries with an improved and more consistent reading experience and will foster discoverability and use of ebooks for all students and faculty at Columbia and beyond.

The first phase of the partnership includes approximately 20,000 ebooks prepared for discovery through CLIO (Columbia's local Blacklight-based catalog) and delivered through the SimplyE mobile app, hosted by LYRASIS. The ebooks are now available to mobile devices used by faculty, students, and staff for full-book download. The goals of the project are to deliver an improved and consistent experience for reading ebooks.

Springer Nature, UC-Berkeley Library sign new open access book partnership

Springer Nature has signed its first ever institutional open access book agreement with the University of California (UC)-Berkeley Library. The agreement will cover a broad range of book titles across all disciplines from humanities and social sciences to sciences, technology, and mathematics. Starting in 2021 and running for at least three years, the partnership will provide open access funding to UC-Berkeley affiliated authors. The open access book titles will publish under the Springer, Palgrave, and Apress imprints, with initial titles set to publish later this year. The books will be published under a CC BY license and readers around the world will have free access to the books via Springer Nature's content platform SpringerLink.

This agreement with UC-Berkeley Library follows the UC systemwide landmark transformative agreement with Springer Nature announced last year to enable UC authors to publish research articles open access in more than 2,700 Springer Nature journals.

ASERL, DOAJ forge new partnership

The Directory of Open Access Journals (DOAJ) has announced a new partnership with the Association of Southeastern Research Libraries (ASERL). The arrangement shines a spotlight on the importance of open access at a time when both libraries and the organizations on which they depend, such as DOAJ, are facing unprecedented financial risks. As a free and independent database, DOAJ indexes more than 15,000 peer-reviewed open access journals from around the world. ASERL is one of the largest regional research consortia in the United States. Its members are world-renowned libraries at research-intensive universities, with a vested interest in open access and open science.

Creativity is the ability to produce a product or idea that is both new and appropriate in a given context, and is essential for innovation, change, and employee satisfaction. Creativity is inherently human, a transferable skill that can be developed and that can improve an individual's personal and professional life, regardless of their level of artistic ability, education, or experience.

Academic libraries are often the first to face budget reductions, hiring freezes, and staff reductions when higher education encounters financial stress, and creativity can seem like either a luxury or an attempt to spur libraries to support the needs of their institution without adequate staff and funding. However, creativity is vital at all levels of the academic library if that library expects to adapt to the current challenges facing higher education. Change is necessary for adaptation, and creativity is essential for change.

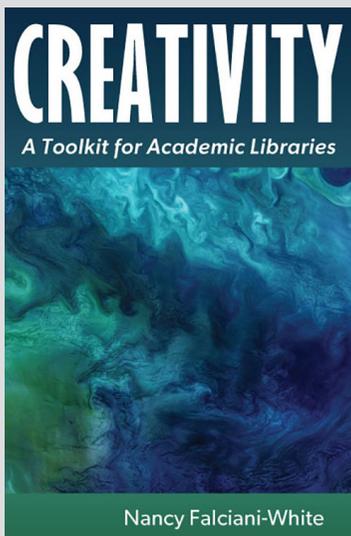
Creativity: A Toolkit for Academic Libraries can help you create, encourage, and

participate in an environment that is conducive to creativity, helping make change a more natural and organic part of the library's culture. The first part, "Understanding Creativity," looks at the psychology of creativity and its use in design thinking, innovation, research, and physical and social environments. The second, "Creativity in Context," examines perspectives of library staff and creativity in academic library literature, and how to enhance personal creativity and foster it in your library.

Greater creativity in librarianship—and creating a culture that values trial and error along with successes—needs to be encouraged by those in library leadership, in the library profession more

broadly, and in institutions of higher education. *Creativity: A Toolkit for Academic Libraries* can be the first step in developing your own creativity and advocating for it across your institution.

The purpose of this initiative is simple, but powerful: to provide solutions, opinion, and constructive discourse grounded in current research on diversity, equity, inclusion, accessibility, belonging, and social justice (DEIA) within the academy and to highlight programmatic initiatives already underway that deserve more coverage.

Choice considers racial justice a cornerstone of its mandate to support academic study and, more broadly, the ends of social justice. Accordingly, this project will develop a pool of knowledge and actionable resources for information professionals, administrators, undergraduates,

and faculty seeking to understand racism from new perspectives and promote diversity on their campuses.

Commenting on this new initiative, Hudson-Ward said, “It is such a great time in history to launch Toward Inclusive Excellence, as there is a convergence of intentional and strategic dialogues, research, teaching, learning, and initiatives happening within the DEIA space in the academy now. Entirely by ‘happenstance,’ the blog’s title transforms into a powerful acronym

(TIE). TIE is the essence of how we think about the unifying and foundational nature of DEIA in the academy. I look forward to partnering with colleagues representing every functional area

within academia to provide rich, thought-provoking, and solutions-centered content that will advance the DEIA discourse in a high-impact fashion.”

The launch follows a number of other initiatives at Choice focused on DEIA, including the addition of a new feature on ChoiceReviews.org that allows subscribers to filter searches with a racial justice facet and an upcoming series of feature-length reviews of important scholarly titles on racial and social justice.

Springshare announces new LibCal mapping features

Springshare has announced the LibCal mapping module, a new tool that visually engages and informs library patrons as they navigate the reservation process. Launched in April 2021, these new features include interactive maps for booking in-person activities and directional maps for event and appointment locations.

Key highlights from LibCal's new, optional mapping features include interactive maps with clickable spaces, seats, and event and appointment locations; color options for map areas based on a user's date and time selection; information bubbles that display each bookable area's capacity, power, and accessibility options on hover; along with nested map capability so users can click from building floor map to a layout map with bookable study rooms or an individual room's map with bookable desks.

Ex Libris, a ProQuest company, has partnered with DataCite, a leading global organization that provides persistent identifiers for research outputs and data. The integration between the Ex Libris Esploro research information management solution and the DataCite service enables researchers and librarians to seamlessly publish institutional research work and facilitates the discovery, citation, and tracking of the publications and underlying datasets via unique identifiers.

Esploro enhances the discoverability of research outputs and data by including the complete set of metadata for each research asset, along with its identifier. When any change is made to research outputs in the Esploro system, the metadata in the DataCite platform is automatically updated.

FireShot is a tool at my fingertips that takes screenshots of webpages and is free to get from the Chrome Web Store. With the aid of FireShot, I captured an entire webpage that exceeded the length of my browser's window and embedded the image in one of my professional posters. The convenience of the single click saved me from the hassle of using the native tool on my PC workstation and having to continually scroll and capture the visible part within the screen area. I also find FireShot handy for attaching snippets of documentations for tickets with service providers, for saving confirmation messages as receipts, and for preserving information on websites I may want to later retrieve.
